Our weighbridge is operational from 6:02am, no truck is able to tare-off until the weighbridge is operational let alone be loaded or dispatched from site. A truck entering the quarry gate off Cabbage Tree Road before 6am is not a breach of our consent conditions, but is not consistent with the Driver's Code of Conduct. The Driver's Code of Conduct was developed to meet the Condition of Consent based on minimising the impacts of haulage trucks on local residents and road users. This includes outlining the consequences of early arrivals, that includes suspension of the Driver from the site where they have been inducted and re-offend. The implementation of driver suspension was in direct response to concerns by neighbours such as yourself and has occurred on numerous occasions. It should be appreciated that the suspension of a driver from the site can be significant for that person, who ultimately may loose their job or income, or it could significantly affect a haulage company's construction contract.  The reason the gate is opened before 6am is based on discussions with neighbouring residents during the approval process to ensure that trucks do not idle at the gate waiting to enter and cause disturbance to residents.
